


The Training Venues

South Yorkshire Police Training Centre Green Lane, Ecclesfield, Sheffield, S35 9WL

With the exclusion of Crime Training Courses, the majority of courses contained within this Prospectus take place at our Ecclesfield site. There are 9 classrooms all of which are fully equipped to meet your needs. The site also has interview rooms, a small resource centre and a gymnasium. The dining room offers a range of hot and cold meals. There are also ample car parking facilities. Although we have no residential accommodation, we are able to provide details of hotels in the local area that operate on a competitive rate.
